Onondaga Lantern Tour

Cave Gatings

Jim Cooley reports that he ~~attended~~ [led the a-regating effort at Lost Man Cave in](#) ~~of~~ [Carter Cave, on the Ozark National Scenic Riverways \(in ONSR\), which effort included Ken Grush, Mark Jones and George](#)

Bilbrey. They removed the old gate and installed a new one. The ~~trip~~ project, funded by the National park Service, took five days and was a great success.

Jim also reported that he and Jim "Crash" Kennedy of Bat Conservation, International led a team to gate Bat Cave in Oregon County, ~~was also gated~~ a 14-day effort which ended yesterday. This cave has the largest gray bat maternity colony in Oregon County. Cavers Ken Grush, Mark Jones, Bill Gee, Mark Lankford, George Bilbrey, and Alicia Wallace assisted, as did MoDOT endangered species biologist Bree McMurray and MDC bat biologist Shelly Colatskie. Alicia was the head welder for the entire effort. An impressive "high line" hauling system was made for this project, which lifted ten tons of steel up to the two cave entrances in a cliff face. An AmeriCorps group from St. Louis also assisted with the project, along with several Forest Service employees. A chute gate design was used on one entrance, and a fly-over gate was built on the other, in order to accommodate the pregnant gray bat females that cannot navigate smaller openings in gates. They project concluded two-and-a-half days early, finished early, and the project ~~was~~ deemed a great success. Ken Grush discovered two

~~A Bat Conservation International representative was present for the trip. A grotto salamanders was discovered~~ in Bat Cave. There is also a rumor that there may be blind cave fish in this cave.

Kings Canyon / Sequoia
